- **Registrations must be accompanied with a scan copy of your passport – for verification of ID and name for IRATA registration purposes.**
- All prices quoted are in Singapore dollars. (Inclusive of GST)
- Payment terms - TT, cash or Singapore Cheque only. **For TT of course payments please included an additional S\$30.00 to account for bank charges. Cheque should be made payable to ‘KB ACCESS PTE LTD’**
- Upon confirmation of booking, a deposit of 50% (Fifty percent) is required.
