

## **Top News**

1. KBA: Successful Completion of Surface Supplied Diving Assessment for Indonesia Divers In Accordance with IMCA Experienced Diver Assessment Requirements.

Over a two-week program from 19 Aug - 02 Sep, the first batch of 12 experienced divers from PT. Advanced Offshore Services (PT. AOS) has successfully completed their Surface Supplied Diver Assessment at TOTAL Indonesie (TEPI) offshore site installation in Balikpapan. The diver assessment was part of PT. AOS and TEPI commitment to bring the competence level of local divers up to international IMCA's standards.

KBA is the only company approved by IMCA outside the

U.K. to conduct the experienced diver assessment program as such we were contracted by PT. AOS and TEPI to conduct the assessment. KBA are pleased to work with both organisations, assist with raising the safety standards and competence of local national commercial divers. The assessment was a resounding success, whereby all parties and individuals gained new knowledge and awareness during the training as well as sharing of experience and skills.

#### 2. KBA: Presentation at Exxon Safety Seminar for Vessel Owners

During the first week of September, Darren Brunton was invited to **Exxon Safety Seminar** to give a presentation to the delegates. The seminar, held in Singapore, was aimed at personnel and contractors.

Darren presented the topic on 'Diver Safety' commencing with an introduction, overview of safe diving practices and emphasised on why SCUBA should not be used for commercial diving activities. He reviewed several case studies and shared the consequences of any misappropriate use often results in 'diver fatality' - injuries, hospitalisations etc.



He further gave an overview of diving equipment, procedures, inherent risks and the importance of emergency planning. The delegates were mainly in the marine sector from Russia (Sakhalin) and Singapore; comments were made that they were not aware of such considerations or means to manage diving safely and welcomed the presentation.

## 3. KBA Europe: Presentation to North Sea Operators Diving Committee (NSODC)

Brendan Kearns was invited to the meeting of the NSODC, held at Shell's Woodbank House facility, Aberdeen. Brendan was tasked to discuss the status of assurance on diving systems and highlighted what has become an abundance of visits that may themselves lead to a down grading of the effect. This once again opened the discussion on sharing of information in ways done in other types of auditing.

The assurance process was discussed in general and demonstrated that auditing was only one part of the process. The failure mode and effects analysis, is a part of the overall assurance and this was discussed as a broad topic that is in need of some guidance to develop a logical boundary in much the same way as DESIGN documents produced by IMCA form the basis of audit terms of reference.

The topic was well received by the audience, all of whom represent bodies with vested interest in diving activities. Stamping over old ground is perhaps a risk however the relevance of latest thinking, the rise in FMEA/FMECA requirements, sharing of information and the simple realisation of how many times vessels operating for oil majors are subject to audit reviews was certainly eye opening.




